Policy Corner: Broadband Grant Programs

It has been a busy start to 2021 here at NTIA. NTIA's Institute for Telecommunication Sciences is [laying the groundwork](#) for a 5G Challenge with the Department of Defense, our Office of Spectrum Management [published](#) a spectrum repurposing report full of exciting progress, and the National Strategy to Secure 5G Implementation Plan has been [released](#). NTIA is also hard at work putting into place the new broadband grant programs authorized by the [Consolidated Appropriations Act of 2021](#). These programs will help bring historically disconnected regions and communities online, with a particular emphasis on Tribal lands, minority communities and minority serving institutions. The BroadbandUSA March webinar will go into greater detail regarding these grant programs. As always, NTIA remains committed to the goal of connecting Americans to affordable and reliable broadband networks.
