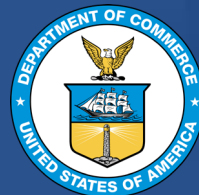




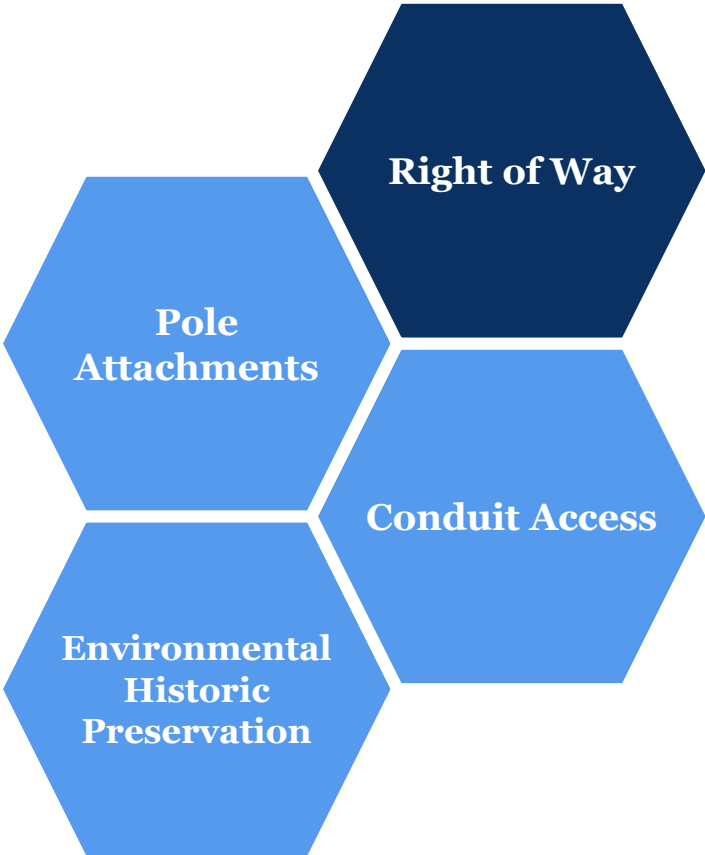

Checklist: Right-of-Way (ROW)

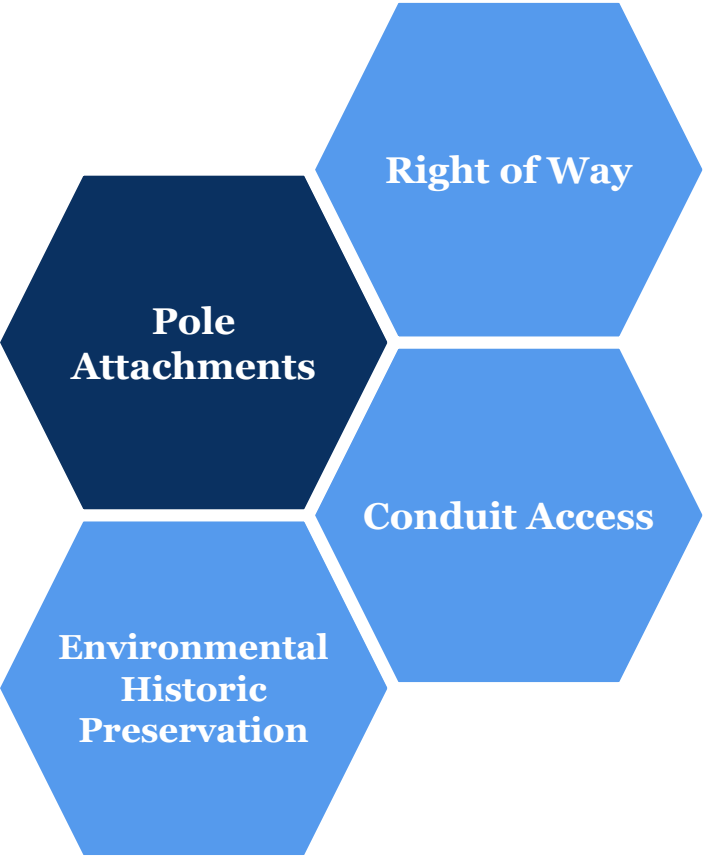
There are four main categories related to permitting that state and local governments must prepare to address, including accessing rights-of-way.

 - What are the unique pole attachment considerations in my area?

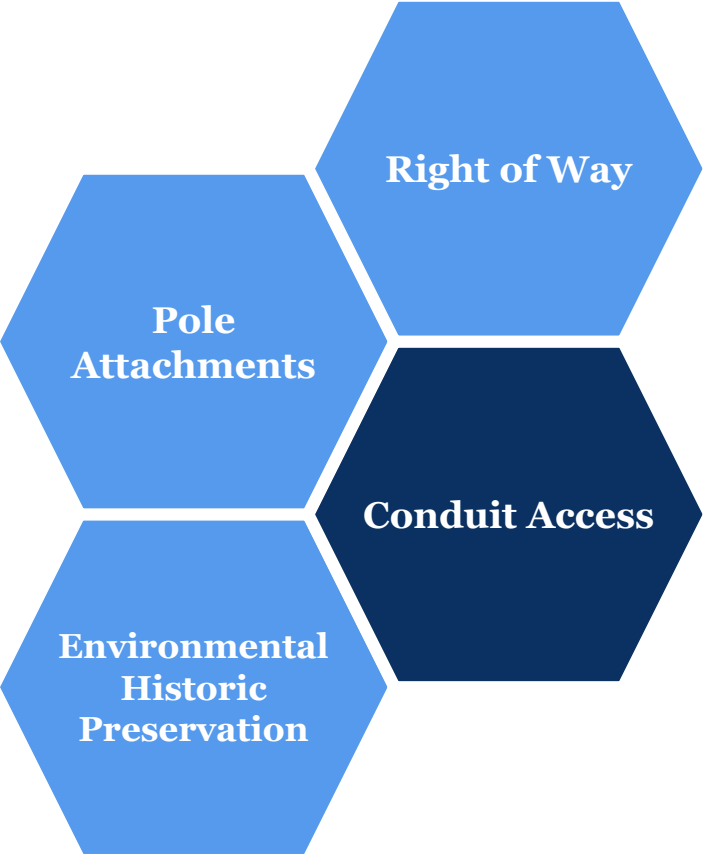

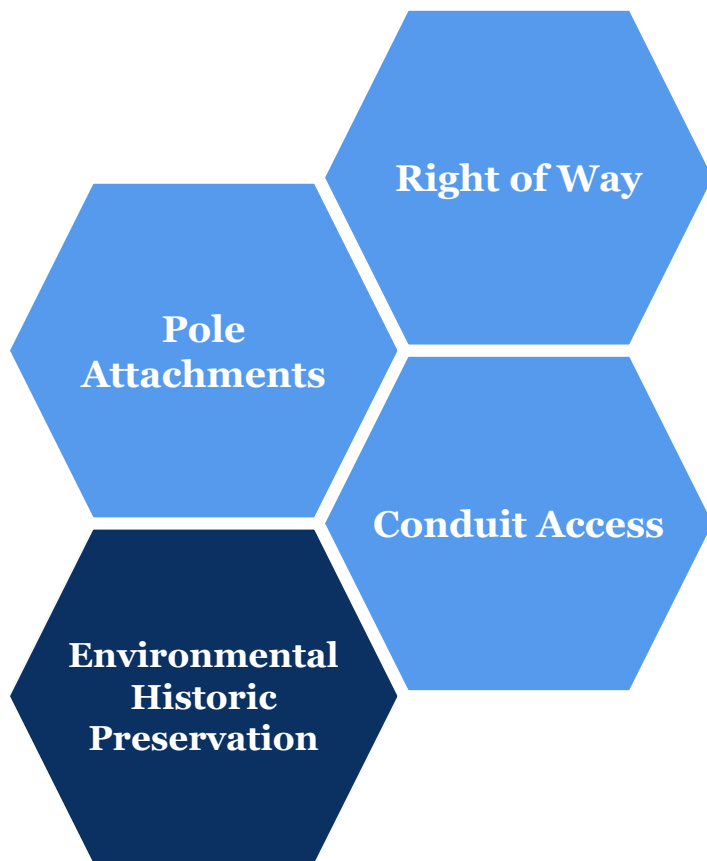

Checklist: Environmental Planning/Historic Preservation

- What are the state and local requirements regarding environment planning and historic preservation?

Stakeholder Engagement

- Which stakeholders should be engaged to review state EHP regulations?
- Which other state agencies are involved in EHP permitting?
- Which federal agencies own land in my state?

Streamlining Permitting

- How to engage state historic preservation officers (SHPOs) on guiding the streamlining of environmental/historic preservation permitting?

Safety & Service Continuity

- How to tackle the potentially lengthy timeline for securing both state and federal environmental/historic preservation permits ?
- Will state agencies cross-coordinate to reduce application processing time?
