Samish reached out to the Affiliated Tribes of Northwest Indians, as well as NoaNet, attended the NTIA and the NTIA conferences to network and receive more sources to directly solicit for a response to the RFQ posting. In addition, the next publication of the RFQ will be sent to a marketing firm to help distribute the publication further.			
7	Please describe whether or not your organization connected NOFO purpose areas to broadband adoption and use or broadband infrastructure deployment work. (600 words or less) Samish connected all purpose areas of Broadband Use and Adoption to our work in that this is a planning grant for digital equity that should help define what the next steps are to close the digital divide for Samish citizens. The outcome of the digital equity plan should include whether or not there is a need to address those purposes. The housing module development work most closely aligns with Broadband Use and Adoption purpose iii in that it aims to improve access to the housing department's use of broadband in providing digital services and an online platform for citizen interaction and inclusion.			
	Please describe your project's achieved accomplishments during this reporting period. (600 words or less) Samish successfully negotiated the scope of work for the housing module development with Arctic IT and executed the contract. Samish IT and housing department met with Arctic IT to define the configuration criteria for the module which was mutually accepted. Samish IT has configured a Dynamics 365 environment and granted Arctic IT staff access			

	to build the solution within a sandbox environment. Currently, the solution is deployed and partially configured to Samish housing specifications. Samish created and published an RFQ for a broadband and digital equity plan and is awaiting responses from quality applicants.
